

Coal gasification plant could start in southern area

CUTLER, III. (AP) — Construction of a coal gasification plant in Southern Illinois could begin by late next year as a result of initial funding of the project by a House subcommittee.

An aide to Rep. Paul Simon, D-Ill., said Tuesday funds for the long-planned project have been earmarked by a House appropriations interior subcommittee. The \$53 million will be used for a Perry County plant to be built near Cutler.

Aide Paul Morrill said a like amount was approved for a similar project in Noble County, Obio.

The announcement ends five years of competition for federal money to build the plant which will convert high-sulfur Illinois coal to synthetic gases usable as alternative fuels.

Mike Dorf, an aide to the subcommittee chairman, Rep. Sid Yates, D-III., said "This is it. This was the main step" in getting the project rolling.

The Perry County demonstration plant proposal was promoted by a consortium of utility companies, the Illinois Coal Gasification Group. In the past year, Simon and his counterparts in Ohio have expressed heightened concern about the energy shortage and recommended full funding of both plants as an end to the competition. The two-plant concept was endorsed by the House in May.

Morrill said the \$53 million is "exactly what we are looking for." He said the money will be used for continued design work and long-range procurement of necessary equipment to build the plant.

If the project is approved by Congress, and licensing and other procedures go smoothly, construction could begin late next year, Morrill said.

Dogs cause injury to postal carriers

"He doesn't bite!" claimed the dog owner to his letter carrier. These were probably the last words the letter carrier heard before the dog proved otherwise.

Last fiscal year 1,620 letter carriers across the Central Region of the U.S.P.S. were injured by dogs - most during summer months. These were all preventable if a little precaution were exercised by the postal customer.

Postmaster Harold E. Campsaid today that certain precautionary safety measures exercised by the public and postal employees will aid the delivery of mail and will reduce dog bite injuries to letter carriers. All letter carriers are being encouraged to follow safety tips in an effort to reduce the dog bite injury rate.

The best thing you can do is to keep the letter carrier and your dog apart — far apart. If your dog is kept outdoors at all times, secure him to a leash away from your mail receptacle and the line of the carrier's entry and exit on your property. If your pet is a house dog, that's the best place for him during delivery time.

Letter carriers are scheduled deliverers. They usually arrive at your home about the same time each day. During this delivery time, keep your dog indoors. These easy to follow rules will keep your mail coming and bring a smile to your letter carrier.

Delivery personnel are reminded that if an unrestrained dog threatens their safety, they should not risk injury. Lincoln Postmaster Harold E. Camp stated, "Persons who do not control their dogs, will not get their mail delivered." He added, "All postal customers can help by reporting stray dogs to the proper authorities."
