

WASHINGTON (AP) livestock disease, vesicular stomatitis, is hanging on stubbornly in parts of the country despite the cold weather, says the Agriculture Department.

The disease is spread primarily by mosquitoes and other insects, and officials had hoped that the cold weather would bring and end to the disease this season.

Officials said Monday, however, that visicular stomatitis has spread into Missouri and California.

John Atwell, deputy administrator of USDA's Animal and Plant Health Inspection Service, said the latest outbreaks appear "to be due to movement of cattle from Colorado after a dairy herd dispersal sale."

In Missouri, a dairy herd became infected, with milk output reduced by 30 percent, he said. In Colorado, a beef herd wask removed from its mountain pasture and came down with the disease 10 days after being brought to its winter feeding

Atwell said that "we think the disease spread from the infected animals through the feed, water and-or salt mineral blocks."

The department investigated possible vesicular stomatitis on 829 farms since early June. Of those, 526 were confirmed as having the disease.

Atwell said vesicular stomatitis "is a transitory disease that is not usually dangerous. However, it is very costly when milk production is reduced by a third or beef cattle lose 100 pounds or more."
