**Dr. Dean Goebel**

Dr. Dean E. Goebel, a Lincoln dentist and prominent community leader, died at 7:40 p.m. Friday, March 6, 1992, at his home.



He was 69. **Dr. Goebel** Doctor Goebel represented the third generation of his family to practice dentistry.

His grandfather, Robert Goebel, began practicing dentistry in 1884. He was followed by his son, Edwin Goebel, in 1912, who was then followed by his two sons, Robert in 1943 and Dean in 1946.

Dean and Robert Goebel shared a Lincoln practice, first on Broadway and then on Pekin Street.

Robert Goebel died in 1983. Dean Goebel retired from the practice in 1984 — 100 years after his grandfather started the first Goebel dental office.

Doctor Goebel, a U.S. Navy veteran of World War II and the Korean War, was the recipient of a Bronze Star. He was a member of the American Legion.

He also held memberships in the G.V. Black Dental Society and Illinois Dental Association.

A member of First United Presbyterian Church, he was a former member of the Lincoln Community High School board and had served on a citizen's advisory committee at the high school.

He was a life member and two-term president of Lincoln Kiwanis Club and president and trustee of Union Cemetery Association.

Doctor Goebel served on the boards of directors at St. Clara's Manor, Abraham Lincoln Memorial Hospital and Kickapoo Park.

Chairman of the Abraham Lincoln Health Care system, he devoted much of his time after retiring to serving as a volunteer worker at Abraham Lincoln Memorial Hospital and the hospital's hospice.

He also was a board member and volunteer for the Oasis Senior Citizen Center in downtown Lincoln and had served on an advisory committee for Central Illinois Light Co.

Selected as the Lincoln Courier's Citizen of the Month in June 1988, he also earned the newspaper's Citizen of the Year award in 1988.

A Lincoln High School graduate, he received his bachelor's and dental degrees from Northwest University.

Doctor Goebel was born July 29, 1922, in Lincoln, a son of Dr. Edwin R. and Irene Eberle Goebel.

He married Mary Finley Holmes on Sept. 2, 1944, in Chicago. She survives.

Also surviving are one son, Douglas M. Goebel of El Paso, Ill.; a cousin, Shirley S. Edwards of Lincoln; and two grandchildren.
